Elections To Be Held at NCOEA Spring Representative Assembly

The election for office of Recording Secretary (2 year term) will be held at the Spring NCOEA Representative Assembly (RA) April 24, 2006.

In addition due to the passage of the Proposed Amendments to OEA's Constitution and Bylaws at the Fall OEA RA, OEA no longer has Commissions. We now have Core Function Committees, which are being added to NCOEA's Executive Committee. The members in these elected positions will represent NCOEA on the OEA Core Function Committees.

The following are the five (5) Core Function Committees:

"Nominations for officers shall be by declaration of intent by candidates sent to the Executive Secretary-Treasurer at least forty-five (45) days prior to the election, by a nominating committee at least thirty (30) days prior to the election, or by nomination from the floor of the representative assembly."
